Each RSU includes tandem dividend equivalents which will vest upon the same schedule as the underlying RSU.
- (2) These RSUs vest ratably over four years in May of each year following the grant year.
- (3) Balance includes original grants of RSUs and dividend equivalents issued in additional RSUs.
