As of the close of business on July 25, 2018, the reporting persons beneficially owned an aggregate of 673,519 shares of the Issuer's Class A Common Stock or 5.1% of the Issuer's Class A Common Stock outstanding. The calculation of the foregoing percentage was based on 13,141,349 shares of the Issuer's Class A Common Stock outstanding as of May 8, 2018, as per the Issuer's Form 10-Q dated May 10, 2018.

Thereafter, as of the close of business on August 3, 2018, the reporting persons beneficially owned an aggregate of 606,924 shares of the Issuer's Class A Common Stock or 4.5% of the Issuer's Class A Common Stock outstanding. The calculation of the foregoing percentage was based on 13,393,712 shares of the Issuer's Class A Common Stock outstanding as of August 1, 2018, as per the Issuer's Form 10-Q dated August 3, 2018. Specifically, as of the close of business on August 3, 2018:

i) Integrated Core Strategies (US) LLC, a Delaware limited liability company ("Integrated Core Strategies"), beneficially owned 605,076 shares of the Issuer's Class A Common Stock; and

ii) Integrated Assets, Ltd., an exempted company organized under the laws of the Cayman Islands ("Integrated Assets"), beneficially owned 1,848 shares of the Issuer's Class A Common Stock, which collectively with the other foregoing reporting person represented 606,924 shares of the Issuer's Class A Common Stock or 4.5% of the Issuer's Class A Common Stock outstanding.

Millennium International Management LP, a Delaware limited partnership ("Millennium International Management"), is the investment manager to Integrated Assets and may be deemed to have shared voting control and investment discretion over securities owned by Integrated Assets.

Millennium Management LLC, a Delaware limited liability company ("Millennium Management"), is the general partner of the managing member of Integrated Core Strategies and may be deemed to have shared voting control and investment discretion over securities owned by Integrated Core Strategies. Millennium Management is also the general partner of the 100% shareholder of Integrated Assets and may be deemed to have shared voting control and investment discretion over securities owned by Integrated Assets.

Millennium Group Management LLC, a Delaware limited liability company ("Millennium Group Management"), is the managing member of Millennium Management and may also be deemed to have shared voting control and investment discretion over securities owned by Integrated Core Strategies. Millennium Group Management is also the general partner of Millennium International Management and may be deemed to have shared voting control and investment discretion over securities owned by Integrated Assets.

Israel A. Englander, a United States citizen ("Mr. Englander"), controls the managing member of Millennium Group Management and may also be deemed to have shared voting control and investment discretion over securities owned by Integrated Core Strategies and Integrated Assets.

The foregoing should not be construed in and of itself as an admission by Millennium International Management, Millennium Management, Millennium Group Management or Mr. Englander as to beneficial ownership of the securities owned by Integrated Core Strategies or Integrated Assets, as the case may be.
